OVERVIEW

Professor Muennich has worked from a comparative-historical perspective on the institutional evolution of financial markets and labour markets in Germany, UK, and the US. His core fields interests are the interplay between ideas and interests for political processes and social movements, the professional field of international Civil Society Organizations, the social, cultural, and moral embeddedness of markets, as well as the methodological connection between macro-comparative sociology and history. He has directed a three-year project on the moral legitimacy of financial markets, anti-finance movements in Germany, Britain, Spain and France, public discourse about finance, as well as emergence and justification of financial and banking profits in different European countries. Moreover, he has worked in the field of sociological theory on institutional change, varieties of capitalism and the history of economic ideas and the welfare state.
